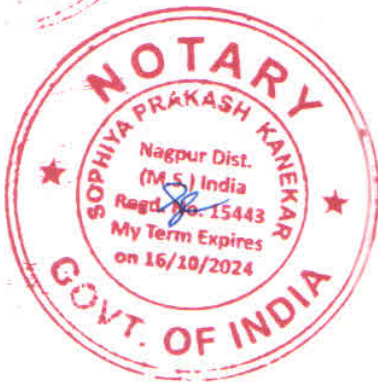

Circular dated 21 July 2000, all the proceeding of according sanctions to the primary school shall be done forthwith and detail report of the said work shall be forwarded to the government immediately.

4) Before intimation of the order of permission of the Government to the primary school, the divisional Education Deputy Director shall get collected the information from the Chief Executive Officer/District Collector of the concerned district whether code of conduct of election (Achar Sanhita) is implemented in the said area and only after the confirmation of said fact, order of permission shall be forwarded/intimated to the concerned Educational Society. 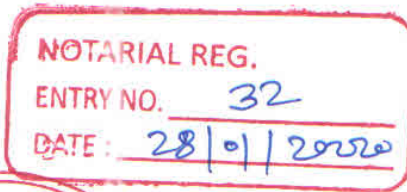
